

NOTICE**FR. BECKERS SCHOLARSHIP FOR 2ND SEMESTER STUDENTS OF MBA**

Applications are invited from eligible students of 2nd Semester of **MBA Course Only** for Fr. Beckers Scholarship offered by the University (Admission Session 2021-22).

Scope of the Scholarship:

- Fr. Beckers Scholarship - **50% Scholarship**, i.e. half tuition fees waiver only from 2nd Semester till the completion of the course for **MBA Course subject to semester-wise renewal condition**.

Academic Requirements for applying:

1. Minimum **75%** or above marks in **both** Class X & XII board examination.
2. Minimum **75%** or above marks with no arrear paper(s) in all preceding semester(s) of the present course.
3. Minimum **90%** or above attendance in all preceding semester(s) of the present course.

Benevolent Requirement:

1. **Annual Family Income is less than ₹ 6,00,000 (six lakhs)**.

Other Requirements:

- The candidate is expected to take part in at least one social work initiative of the University in the preceding semester.
- The candidate must not have any record of disciplinary action against him/her in any of the preceding semester by the disciplinary committee of the University.
- There is **NO FEE PENDING** for the student.

Mandatory documents required to apply for Fr. Beckers Scholarship:

1. **Income Tax Return or TDS Statement or Form 16(A)** of parent(s)/guardian for the last two financial years (i.e. FY 2019-2020 and FY 2020-2021)
2. **Bank Statement or Bank Passbook** of parent(s)/guardian for last one year (1st January, 2021 to 1st January, 2022)
3. **Latest Salary Statement** issued by employer or **Latest Pay Slip** issued by employer or **Income Certificate (in case of Business)/Annual Balance Sheet (in case of Business)** issued by competent Govt. authority of parent(s)/guardian
4. **Date of Birth Proof** (Class X Admit Card/Registration Card/Marksheet/Pass Certificate/Aadhaar/ Birth Certificate)
5. Marksheet and Pass Certificate of Class X (Matriculation)
6. Marksheet and Pass Certificate of Class XII (Higher Secondary)
7. Final Marksheet/Consolidated Marksheet and Degree Certificate/Provisional Certificate of the preceding Semester(s) of the UG Course
8. Document(s) related to any previous Scholarship or Govt. Aid/Assistance (if received at the last attending School/College/Institute/University)
9. **Any Government ID Proof** (Aadhaar/PAN/Voter ID/Passport)
10. A 'Letter of Recommendation' from the Parish Priest (*for Christian Students only*)

Processes of Application:

- Eligible students are requested to apply as per the proforma attached along with this notice as Annexure-I.
- The students are requested to **submit the hardcopy of the application form along with self-attested photocopies of all the supporting documents** to The Assistant Registrar, St. Xavier's University, Kolkata, Premises No. IIIB-1, Action Area IIIB, P.S. New Town Kolkata 700 160, West Bengal, India.
- The hardcopy may be sent by post/courier or may be dropped at the University Reception with the envelope clearly marked as '**Application for Fr. Beckers Scholarship**' on top of the envelope.

Last date for receiving the hardcopy of the application form along with self-attested photocopies of all the supporting documents: **29th January, 2022** (Saturday)

Important Instructions for Applicants:

1. Possessing of mere eligibility does not ensure grant of scholarship.
2. The decision of the Vice-Chancellor of the University shall be final and binding with respect to grant of scholarship.
3. Any canvassing by or on behalf of the candidates regarding their selection for the above scholarship shall be considered as disqualification.
4. Incomplete application with/without supporting documents will be summarily rejected.
5. The scholarship committee reserves the right to review, modify or cancel the award due to changes in academic progress or general conduct of the student in accordance with the University rules and regulations.
6. If the candidate is found to furnish any false information or recommended for any disciplinary action by the disciplinary committee at any stage of the course, his/her scholarship may stand revoked.
7. Scholarship may not be granted if the application is received after the last date.
