

NOTICE**RENEWAL OF SCHOLARSHIP FOR 3rd AND 5TH SEMESTER STUDENTS**

Applications for renewal of scholarships for odd semester (Academic Session 2022-2023) are invited from eligible students who are currently availing scholarship from the University.

Types of Scholarship:

Academic Requirement for Renewal:

1. Minimum 75% attendance in all previous semesters.
2. No arrear paper(s) in any preceding semesters.

Other Requirements:

- There is NO FEE PENDING for the student.
- The candidate must not have any record of disciplinary action against him/her in any of the preceding semester by the disciplinary committee of the University.
- In case of outstanding sports performance, besides the income criteria, the candidate must have a podium finish in any individual/team event of national or international level.
- The candidate is expected to take part in at least one social work initiative of the University in the preceding semester.

Processes of Application:

Online Application: Application for scholarship will be accepted only in online mode through the student portal. No other mode of application will be accepted.

Last Date for Online Application: **31st May, 2022**

Last date for receipt of hardcopy of the application with self-attested photocopies of all the supporting documents: **31st May, 2022**

Note:

1. Possessing of mere eligibility does not ensure grant of scholarship.
2. The decision of the Vice-Chancellor of the University shall be final and binding with respect to grant of scholarship.
3. Any canvassing by or on behalf of the candidates with regard to their selection for the above scholarship shall be considered as disqualification.
4. Incomplete application with/without supporting documents will be summarily rejected.
5. The scholarship committee reserves the right to review, modify or cancel the award due to changes in academic progress or general conduct of the student in accordance with the University rules and regulations.
6. If the candidate is found to furnish any false information or recommended for any disciplinary action by the disciplinary committee at any stage of the course, his/her scholarship may stand revoked.
7. Scholarship may not be granted if the application for renewal is received after the last date.

All applicants are requested to upload the scanned copy of the following documents during online application and submit the self-attested photocopies of the same along with the print-out of the scholarship application form:

1. Income Tax Return/TDS Statement/Form 16 of parent(s)/guardian for the last financial year (i.e. FY 2021-22 or ITR AY 2022-23)
2. Bank Statement/scanned copy of Bank Passbook of parent(s)/guardian for last one year (1st May, 2021 to 1st May, 2022)
3. Latest Salary Statement issued by employer/Latest Pay Slip issued by employer/Income Certificate issued by competent Govt. authority (in case of business) of parent(s)/guardian.
4. Any other document(s) related to the loss of job or reduction of income during the COVID-19 pandemic period.

Important Instruction:

Applicants need to take the printout of the online application and submit it to the Office of the Registrar along with self-attested copies of all the requisite supporting documents as mentioned above.

The envelope should be clearly marked "**Application for Renewal of Scholarship for Odd Semester, 2022-2023**" on the top of the envelope and the name, course & semester of the applicant should also be mentioned.
