NOTIFICATION FOR RENEWAL OF SCHOLARSHIPS FOR EVEN SEMESTER, ACADEMIC SESSION 2025-26

(For all students who are currently availing University scholarships)

Applications for renewal are invited from the students **who are currently availing** University scholarships for the upcoming Even Semester, Academic Session 2025-26.

Mandatory Requirements:

- 1. The student must fulfil the academic & income criteria as given in **Annexure-I**. Only the attendance in the regular classes will be considered. Attendance in any additional classes/special classes, etc. will **not** be considered.
- 2. The student must not incur any arrear/backlog paper(s) in the current semester or any preceding semester(s).
- 3. There are **no fees due** from the student up to the current semester.
- 4. The student must not have any record of disciplinary action against him/her in the current semester or in any preceding semesters by the Disciplinary Committee of the University.
- 5. The student must not be a recipient of any Government Scholarship or any other external Scholarships or Financial Assistance.

Documents regarding Proof of Income: (Not required to apply for Merit-based scholarships)

- 1. **Income Tax Return/TDS Statement/Form-16** of parent(s)/guardian for the Financial Year 2024-2025 i.e., ITR Assessment Year 2025-26 (April, 2024 to March, 2025).
- 2. **Annual Information Statement (AIS)** downloaded from the Income Tax e-filing portal of parent(s)/guardian for the Financial Year 2024-2025. <u>AIS of both parents/guardian(s) are mandatory.</u>
- 3. **Bank Statement/Bank Passbook** of parent(s)/guardian **for last six months**, i.e. from 1st May, 2025 to 31st October, 2025.
- 4. Latest Salary Statement issued by the employer or Latest Pay Slip issued by the employer or Latest Pension Statement or Income Certificate (in case of business) for the last financial year issued by competent Govt. authority of parent(s)/guardian. Please note that the Income Certificate of parent(s)/guardian must be issued by a Group-A Gazetted Officer (i.e. Executive Officer/Chief Engineer or above) if residing in a Municipal Area or, BDO/Jt.BDO or above if residing in Rural Area. The proforma for Income Certificate is enclosed herewith as Annexure-II.

Instructions for Applying:

- 1. Applicants need to login to the student portal to apply for renewal of scholarship for the upcoming semester by clicking on the appropriate link.
- 2. After the completion of their application, the students are required to take a printout of the final online application form which must be signed by their parents and themselves.
- 3. The application form along with self-attested copies of all the supporting documents listed above may be submitted by hand/post/courier to the <u>Office of the Registrar</u>, St. Xavier's University, Kolkata, Administrative Building (1st floor).

Last Date for submission of Scholarship Application in Online Portal: 1st December, 2025

Last Date for submission of Hardcopy of Scholarship Application: 2nd December, 2025

Important Notes:

- 1. Mere possession of eligibility does not ensure the grant of scholarship.
- 2. Scholarship applications may not be considered if the hardcopy is received after the due date.
- 3. Any canvassing by or on behalf of the student with regard to their selection for the above scholarship shall be considered as disqualification.
- 4. Incomplete application form with/without supporting documents will be summarily rejected.
- 5. The Scholarship Committee reserves the right to review, modify or cancel the grant of Scholarship due to changes in academic progress or general conduct of the student in accordance with the University rules and regulations or due to the unavailability of funding from the sponsoring body.
- 6. If the student is found to furnish any false information or is recommended for any disciplinary action by the Disciplinary Committee at any stage of the course, his/her scholarship shall stand revoked.

- 7. The University may seek additional information/supporting documents from the student, if required, on the basis of the information provided in the Scholarship Application form and the enclosed documents for further scrutiny.
- 8. The Deans of the respective Departments/Faculties/Schools may call the student and their parent(s)/guardians to appear before them for a short interview.
- 9. The decision of the Vice-Chancellor of the University shall be final and binding with respect to grant of scholarship.
- 10. If a student is unable to meet the above-mentioned requirements for renewal of the scholarship in any of the subsequent semester(s), his/her scholarship shall be cancelled for the remaining duration of his course.
- 11. The Scholarships sponsored by external benefactors is subject to the availability of funds. In case a student applying for the renewal of Scholarships funded by external benefactors is found eligible, he/she may be granted University Scholarship for the same amount.
- 12. The University will not be responsible for postal delay, if any.
