- I. **Ignatius Scholarship** is applicable for students with 40% or more of the following Disabilities as specified in the **Rights of Persons with Disabilities Act 2016**: Blindness, Low Vision, Leprosy cured persons, Hearing Impairment (deaf & hard of hearing), Locomotor Disability, Dwarfism, Intellectual Disability, Mental Illness, Autism Spectrum Disorder, Cerebral Palsy, Muscular Dystrophy, Chronic Neurological Conditions, Specific Learning Disabilities, Multiple Sclerosis, Speech and Language Disability, Thalassemia, Haemophilia, Sickle Cell Disease, Acid Attack Victim, Parkinson's Disease, and Multiple Disabilities.
- II. For **Nihil Ultra Scholarship**, the student must have a minimum **95%** marks in both Class X & Class XII board examinations. Marks will be calculated as per university admission guidelines, i.e. best of four (out of 400) in Class XII with English compulsory excluding vocational/elective subjects and best of five (out of 500) in Class X with English compulsory excluding vocational/elective subjects.
- III. For **Lafont Scholarship**, the student must have a minimum **90%** marks in both Class X & Class XII board examinations. Marks will be calculated as per university admission guidelines, i.e. best of four (out of 400) in Class XII with English compulsory excluding vocational/elective subjects and best of five (out of 500) in Class X with English compulsory excluding vocational/elective subjects.
- IV. The academic criteria for **Xavier Scholarship** in the 1<sup>st</sup> Year of MBA is **85%** attendance in both 1<sup>st</sup> & 2<sup>nd</sup> Semesters. Only attendance in regular classes will be considered, attendance in additional classes will **not** be considered. Further, there must **not be any arrear papers** in both 1<sup>st</sup> & 2<sup>nd</sup> Semester examination, i.e. all the papers in the 1<sup>st</sup> Year must be cleared on the first attempt.

#### **Other Mandatory Requirements:**

- 1. The student must fulfil the academic & family income requirements as mentioned above. Only the attendance in the regular classes will be considered. Attendance in any additional classes/special classes, etc. will **not** be considered.
- 2. The student must not incur any arrear/backlog paper(s) in the current semester or any preceding semester(s).
- 3. There are **no fees due** from the student up to the current semester.
- 4. The student must not have any record of disciplinary action against him/her in the current semester or in any preceding semesters by the Disciplinary Committee of the University.

5. The student must not be a recipient of any Government Scholarship or any other external Scholarships or Financial Assistance.

## **Documents regarding Proof of Income:** (Not required to apply for Merit-based scholarships)

- 1. Income Tax Return/TDS Statement/Form-16 of parent(s)/guardian for the Financial Year 2024-2025 i.e., ITR Assessment Year 2025-26 (April, 2024 to March, 2025).
- 2. Annual Information Statement (AIS) downloaded from the Income Tax e-filing portal of parent(s)/guardian for the Financial Year 2024-2025. AIS of both parents/guardian(s) are mandatory.
- 3. Bank Statement/Bank Passbook of parent(s)/guardian for last one year, i.e. from 1st November, 2024 to 31st October, 2025.
- 4. Latest Salary Statement issued by the employer or Latest Pay Slip issued by the employer or Latest Pension Statement or Income Certificate (in case of business) for the last **financial year** issued by competent Govt. authority of parent(s)/guardian. Please note that the Income Certificate of parent(s)/guardian must be issued by a Group-A Gazetted Officer (i.e. Executive Officer/Chief Engineer or above) if residing in a Municipal Area or, BDO/Jt.BDO or above if residing in Rural Area. The proforma for Income Certificate is enclosed herewith as **Annexure-I**.

## **Other Mandatory Documents:**

- 1. Proof of admission (i.e. Admission & Semester Fee Payment Receipt).
- 2. Final/Consolidated Marksheets and Pass/Degree Certificates of Secondary (Class X), Higher Secondary (Class XII) and Graduation (for PG students only).
- 3. Document(s) related to any previous Scholarship/Fees Concession/Financial Aid or Assistance granted by any Government body/NGO/Organization, if received at the last attending School/College/Institute/University.
- 4. Certificates of any Extracurricular & Sports Achievements/Podiums at the last attending institution/school/state level/national/international level.
- 5. Letter of recommendation from the Parish Priest (for Christian Students only).

# **Instructions for Applying:**

- Students who are in 1st Semester need to login to the student portal and apply for a fresh Scholarship by clicking on the appropriate link.
- After the completion of their application, the students are required to take a printout of the final online application form which must be signed by their parents and themselves. Students who are in 3<sup>rd</sup>/5<sup>th</sup>/7<sup>th</sup>/9<sup>th</sup> Semesters and applying for Arrupe Scholarship are required to take
- a print-out of the form enclosed along with this notification as **Annexure-II** and fill it by hand.
- The application form along with self-attested copies of all the supporting documents listed above may be submitted by hand/post/courier to the Office of the Registrar, St. Xavier's University, Kolkata, Administrative Building (1st floor).

Last Date for submission of Scholarship Application in Online Portal: 1st December, 2025

Last Date for submission of Hardcopy of Scholarship Application: 2nd December, 2025

## **Important Notes:**

- 1. Mere possession of eligibility does not ensure the grant of scholarship.
- 2. Scholarship applications may not be considered if the hardcopy is received after the due date.
- 3. Any canvassing by or on behalf of the student with regard to their selection for the above scholarship shall be considered as disqualification.
- Incomplete application form with/without supporting documents will be summarily rejected.
- The Scholarship Committee reserves the right to review, modify or cancel the grant of Scholarship due to changes in academic progress or general conduct of the student in accordance with the University rules and regulations or due to the unavailability of funding from the sponsoring body.
- If the student is found to furnish any false information or is recommended for any disciplinary action by the Disciplinary Committee at any stage of the course, his/her scholarship shall stand revoked.
- The University may seek additional information/supporting documents from the student, if required, on the basis of the information provided in the Scholarship Application form and the enclosed documents for further scrutiny.
- The Deans of the respective Departments/Faculties/Schools may call the student and their parent(s)/guardians to appear before them for a short interview.

- 9. The decision of the Vice-Chancellor of the University shall be final and binding with respect to grant of scholarship.
- 10. If a student is unable to meet the above-mentioned requirements for renewal of the scholarship in any of the subsequent semester(s), his/her scholarship shall be cancelled for the remaining duration of his course.
- 11. The Scholarships sponsored by external benefactors is subject to the availability of funds.
- 12. The University will not be responsible for postal delay, if any.
