- 1. Review is offered for both Regular and Arrear theory papers. No Review is offered for Practical Papers, Project Papers, Assignments and Field Work, etc.
- 2. The students have to apply in online mode available on University Website (www.sxuk.edu.in) through student's login and such application for Re-evaluation shall be restricted to a maximum half the number of Theoretical Papers of that Semester only.
- 3. The Review Marks will stand irrespective of whether the Marks are more or less than the original Marks.
- 4. The applications are invited from the students from **June 14, 2025** to **June 20, 2025** for Review without any late fee i.e., **INR 500/- per paper**.
- 5. The applications will also be accepted from the students from **June 21, 2025** to **June 27, 2025** for Review with late fee i.e., **INR 1000/- per paper**.
- 6. No application for 'Review' will be entertained thereafter under any circumstances.
- As soon as the COE Office receives confirmation from the Bank as regards the necessary payment, the COE Office will proceed with the Review Work, and its Result(s) will be published in the due course.
- 8. A paper may be sent for a second assessment, if the Marks after the Review is increased/reduced by 10% from the original Marks given by the First Evaluator. Such 'Additional Review', if necessary, will be automatically processed by the COE Office at no extra cost.
