Interview for the short-listed candidates may be held between 02.07.2024 to 05.07.2024. The candidates will be shortlisted based on the information of the application form. Short-listed candidates will be communicated through mail on 28.06.2024. On the day of verification of documents if it found that any candidate has given false or wrong information and does not qualify the eligibility criteria, the candidature of the applicant will be cancelled, and he/she will not be allowed to appear for the interview.

The selected candidate/s will be required to join with effect from 9th July 2024.
