ADMISSION PROCEDURE:

- The candidate is required to come to the university physically for admission. Foreign candidate (if any) is requested to contact us at admission.as@sxuk.edu.in for additional procedures before the admission.
- At the time of verification of documents if it is found that the candidate has provided any wrong information or false document/s or does not qualify as per the eligibility criteria, the candidate will not be eligible for admission.

Date of Admission: 05.06.2025 (Thursday)

Payment of Fees:

- The selected candidate is required to make the fee payment [The Admission Fee + Fee for Semester I + Security Deposit(refundable)] within the specified time for the purpose of admission, failing which, he/she will not be eligible for admission.
- After making the payment (online /other payment mode) the candidate needs to take print out of the system generated payment receipt. For online payment the receipt will be generated instantly and for other payment modes the receipt will be generated after realization of the payment (usually three working days after making the payment).

Fee Payment Process:

For payment, the following steps are to be followed:

1. Candidates are required to go to the link <https://www.sxuk.org/PGlogin.aspx> and use the credentials – **Application Code (Refer to Selection List), Registered Email ID, Registered Mobile Number** to log in to your portal.
2. Kindly fill the details of your Father/Mother/Guardian as asked. Click on the **Submit** button after doing so. Fill up the details carefully as the data once entered and submitted cannot be edited by the candidate at a later stage. It can only be done on request at the time of physical verification of documents. **Please note that the candidate will not be able to proceed to the payment page without filling up this data.**
3. Candidates will thereafter be redirected to the '**Admission and Course Fees**' page. Candidates need to proceed by clicking the button 'Proceed' after clicking on the checkbox of the required fee to be paid. The Admission Fee and Course Fee are to be paid together.
4. The next page will display the total payable amount along with the options to pay through the following Gateways (i) Bill Desk, (ii) ICICI Bank (iii) Axis Bank & (iv) HDFC Bank
5. Candidates may pay through any Credit Card/Debit Card/Net Banking of any bank by selecting any one of the Payment Gateway (i) Bill Desk, (ii) ICICI Bank, (iii) Axis Bank (iv) HDFC Bank to make the Payment.
6. Candidates willing to pay through DD/NEFT/RTGS may proceed with the ICICI Bank Payment Gateway or Axis Bank Payment Gateway. On selecting any of the options from DD/NEFT/RTGS, candidate is required to generate the challan and proceed further.
7. In case of DD, please ensure that the amount mentioned in DD must have an **additional amount of Rs. 20 (for ICICI Bank)/ Rs. 24 (for Axis Bank)** and the date in Challan must be same as mentioned in the DD. After the generation of the challan, you are required to deposit the DD along with the Challan in any ICICI / Axis Bank Branch respectively.
8. In case of NEFT/RTGS you are required to generate the Payment Challan from the option provided and visit your Bank/Branch for processing the Payment. Please ensure that the amount should match exactly with the payable amount mentioned in the challan (including service charges, apart from the bank charges).
9. In case of CASH Payment, you are required to generate the Payment Challan from Axis Bank gateway and deposit the same in nearest Axis Bank Branch.

10. UPI payment option is available under HDFC Payment gateway.

12. **Cheque Payments are not allowed.**

Documents to be carried by the candidate/s on the day of admission (originals and a set of photocopies):

1. Payment receipt/s for fees [The Admission Fee + Fee for Semester I + Security Deposit(refundable)].
2. Online Application Form and Bank/Online payment receipt for Application (₹1,000).
3. Mark sheets and Certificates from Class X, Class XII, and Under Graduation and Post Graduation (If Any). Those who will be completing their graduation in 2025 are required to bring their UG Marksheets at least till Semester V/VII/IX (in case of a 4-year/5-year degree course). Digital mark sheets/certificates may be accepted only if it is duly attested and stamped by a competent authority like the Principal/Vice-Principal/Dean/Controller of Examinations of the institution. A copy of Final marksheets to be submitted by **15th October 2025**. However, candidate must fulfill the minimum eligibility criteria* as mentioned in the admission announcements/notifications.

Eligibility Criteria*

1. Candidate must fulfill the required course criteria and minimum marks criteria as mentioned in admission announcements/notifications.
2. Students must not have any arrear/supplementary paper/subject till the Semester IV/ Year II (Applicable for 3-Year Course) or Semester VI/ Year III (Applicable for 4-Year Course) or Semester VIII/ Year IV (Applicable for 5-Year Course).
3. No candidate shall be eligible for admission after a lapse of more than Five Years from the year of passing the previous qualifying examination.
4. The candidate must have Honours/Major degree (If applicable for the course).

Scholarship:

The candidates taking admission will be required to pay the fees [**Admission Fee + Fee for Semester I + Security Deposit (refundable)**] before the admission and may apply for the scholarship from 2nd Semester onwards.
