- I understand that indulgence in any anti-institutional or anti-social activity in the Hostel is punishable and I will be liable for severe penalties and punishments for indulging in such acts.
- I agree not to indulge in groupism of any type and would live in harmony with others in the Hostel.
- I declare that I am physically and medically fit to stay in the Hostel. I also declare that every information about my being medically / psychologically unfit in any degree or manner has been brought to the information of the University authority at the time of applying for Hostel accommodation. I will not hold the University responsible for any consequence which will be a result of my non-disclosure and will not request for refund of Hostel fees.
- I undertake to conduct myself as a diligent student within the Hostel and in the vicinity and not misbehave in any manner including using inappropriate languages, physical tiffs and fights with the other inmates/employees/and others in the Hostel.
- I agree not to cook, not to use any electric gadgets, ironing cloths inside the room. I will not cause any damages whatsoever, including defacing the property of the Hostel and I understand that I will be liable for penalties and punishments for doing so. I will not damage any furniture or fixtures of the room allotted to me and will agree to pay for the damage if any.
- I accept to stay within the Hostel premises by the stipulated time and will not stay out without proper prior permission from the concerned authorities. I undertake to abide by all the rules that govern my stay in the Hostel and also all the changes to the rules that may be made from time to time.
- In order to promote individual study in the Hostel rooms, I shall ensure silence in the Hostel, particularly in my room and shall not play loud music without using headphone or shall carry on any activity which will affect the study atmosphere in the Hostel premises.
- I shall not allow any visitor to stay in my room, failing which I may be asked to vacate the room and leave the Hostel immediately.
- I shall not indulge in ragging, hooliganism or any kind of indiscipline in any form or involve myself in any kind of criminal activities.
- I will not possess/consume/carry any kind of alcoholic drinks and/or any kind of narcotic drugs and psychotropic substances (including but not limited to weed, ganja, marijuana, heroine, chewing pan,

gutka, tobacco, cigarettes, e-cigar, distribution of any drug or any objectionable items) as specified under NDPS Act, 1985 (as amended from time to time) in my hostel room or hostel premises or University campus and shall report such action of other students in other rooms to the Hostel authority when it comes to my knowledge.

- I am aware that the Hostel Management Team may inspect/enter any room to satisfy themselves that I maintain high standards of self-discipline as and when required.
- I understand and agree to the condition that:
 - i) Hostel fees once paid will not be refunded under any circumstances.
 - ii) If I fail to pay the Hostel Fees with the stipulated date as notified, I will not be allowed to stay in the allotted Hostel room and/or I will be required to vacate the Hostel room by 1st July or 2nd January as the case may be.
- Finally, I agree to abide by all the rules and regulations of the University with regard to Hostel stay, which may be framed from time to time and accept the decision of the management in all respects as final and binding on me for compliance.
- The Hostel Management will be at liberty to expel me without assigning any reasons whatsoever for such gross misconduct. If caught violating the Hostel Policy, Rules and Regulations (Revised), I am ready to vacate the Hostel immediately and accept the decision taken by the University as final.
- I hereby indemnify St. Xavier's University, Kolkata and its authorities, etc from any loss or injury and damage to property during my stay in the Hostel which may arise due to natural calamities or any other acts, deeds or things, beyond the control of the University authority.
